Prize(s): Saturday Prize: One (1) winner will receive one (1) \$100 Gas Gift Card. Prize value is \$100.00. **Sunday Prize:** One (1) winner will receive one (1) \$200 Visa® Gift Card. Prize value is \$200.00 Prize(s) cannot be substituted for cash.

Winners need not be present to win. A Meriwest Credit Union Employee will notify winners by phone during the week of August 19-23, 2019. All entries become the property of the Sponsor and will not be returned.

How to Win: On Saturday, August 17, 2019, one (1) random drawing will be held for (1) \$100 Gas Gift Card at approximately 6:00 p.m. and on Sunday, August 18, 2019, one (1) random drawing will be held for (1) \$200 Visa® Gift Card at approximately 5:00 p.m. All times are Pacific Time. If winners are not present at sale, a Meriwest Credit Union employee will call the winner(s) during the week of August 19-23, 2019. The prize winner(s) will be randomly chosen from all eligible entries received in accordance with these Official Rules. If an entry form is drawn, but judges are unable to determine the winner because of illegible writing or information deemed necessary to declare a winner is missing, that entry form will be disqualified and another entry will be randomly selected. The decision will be final and binding. The winners will be notified by telephone and must meet all eligibility requirements, including the execution and return of all necessary releases and affidavits.
